## Crime Spree Ends with Multiple Arrests

**Onondaga County, New York** – The Onondaga County Sheriff's Office and several other police agencies across Onondaga & Oswego County have been investigating numerous burglaries, stolen vehicles and larcenies from vehicles between September 17th, 2017 and September 20th, 2017. These included incidents in the Towns of Salina, Clay, Cicero, Van Buren & Lafayette as well as the Villages of Baldwinsville and Phoenix.

On Wednesday morning, at approximately 4:50 am, deputies along with numerous police agencies responded to reports of vehicle larcenies in progress in the Darby Farms subdivision in the Town of Cicero. As the first deputy, along with a Cicero Police Officer arrived in the area, they observed two previously reported stolen vehicles, one of which was occupied by two suspects. Those suspects were immediately taken into custody, while additional suspects fled the area on foot. Subsequent search resulted in Deputies locating two additional suspects. A fifth suspect was located and taken into custody at his residence that afternoon. As a result of these incidents, 6 stolen vehicles have been recovered and numerous items of stolen property have been recovered. The following individuals have been arrested and charged;

**Cheyne Dolan** (23) of Park Street, Syracuse has been charged with Burglary 2nd degree (3cts) Grand Larceny/Stolen Vehicle (2cts) & Grand Larceny (6cts)

**Delvon Durham** (21) of Griffiths Street, Syracuse has been charged with Burglary 2nd degree (3cts) Grand Larceny/Stolen Vehicle (2cts) & Grand Larceny (6cts)

**Brant Richardson** (21) of Kirkpatrick Street, Syracuse has been charged with Burglary 2nd degree (3cts) Grand Larceny/Stolen Vehicle (2cts) & Grand Larceny (6 cts)

**Nefikah Handford** (23) of Winton Street, Syracuse has been charged with Grand Larceny/Stolen vehicle (2cts) & Grand Larceny (5cts)

**JUVENILE** (13) of Syracuse has been charged with Grand Larceny/Stolen Vehicle (2cts) & Grand Larceny (5cts)

All adult suspects were arraigned in the Town of Cicero Court late this morning and remanded to the Justice Center. The juvenile was released to a parent and will face juvenile proceedings in Family Court.

Deputies and Detectives continue to follow up on all the recovered property and are still in the process of obtaining search warrants for some of the recovered vehicles. To date we are aware of 5 residential burglaries, 6 stolen vehicles and 20 vehicles larcenies. The investigations are ongoing and additional charges are expected. Numerous police agencies have been involved including the NYSP, Cicero PD, Baldwinsville PD, Phoenix PD and the Syracuse PD.
