ONONDAGA COUNTY PISTOL LICENSE RULES & REGULATIONS

TYPES OF PERMITS

- 1. CARRY CONCEALED/NO RESTRICTIONS: Entitles you to carry your handgun concealed on your person 24/7 **except** in New York City and where State Law prohibits (i.e. Federal, State, County, City Office Buildings, Courthouses, Schools, Banks, Public Buildings, and Posted Land)
- 2. CARRY CONCEALED WITH RESTRICTIONS: Entitles you to carry your handgun concealed on your person while you are performing the functions listed on your permit. **However**, while in transit to perform those functions, all handguns MUST be secured in a lock box with a trigger lock and ammunition secured separately. Examples of types of restrictions are employment and security and will be listed on your permit. All weapons being added for work that are owned by your employer must be added to your permit with a letter from the employer.
- 3. SPORTSMAN: Entitles you to use your weapon for the purposes of hunting, target shooting, camping, hiking, & competition shooting. All handguns being transported MUST be in a lockbox with a trigger lock and ammunition secured separately.

All permits are valid until revoked/suspended

Paper permits cannot be laminated as changes need to be made to them

CHANGES TO YOUR PERMIT

All changes such as adding/removing weapons, name changes, and address changes need to be changed within 10 days of the change. There is a \$3 fee.

GUNS ADDED FROM A FEDERAL FIREARMS LICENSE (FFL) DEALER

All weapons being added from a dealer must be on the FFL's letterhead with their contact information and FFL #. All weapons must be **paid for in full** before being added onto any permit.

GUNS ADDED FROM A PRIVATE TRANSACTION (Immediate Family Only)

The only private sale transfers allowed are ones between immediate family members, i.e. spouses, children, and step children. All other transactions must be done through an FFL Dealer.

ALL GUNS PURCHASED OUT OF STATE

Weapons purchased out of state MUST be transferred from an out of state dealer to a NYS FFL Dealer, ONLY. **Do not bring any pistol and/or revolver into NYS from any other state.**

JOINT USE

Joint use of a weapon is permitted between the applicant and one member of their immediate family, living in the same household. Joint use does not apply to friends.

DUPLICATE PERMIT (CONVERTING FROM PAPER TO PLASIC STYLE PERMIT)

Applicant must have an appointment for this service. Application can be obtained on our website. Please call us to set up your appointment before sending in your paperwork. There is an \$8 fee.

STOLEN/LOST HANDGUNS

Any handgun that is lost or stolen needs to be reported to a police agency ASAP. A copy of the police report must then be brought to the Pistol License Unit. All lost/stolen guns will remain on the pistol permit until they are recovered. It is the Pistol License holder's responsibility to keep all handguns locked and secured while not in use. This means handguns must be in a safe that cannot be easily broken into or removed from the premises.

MOVING OUT OF STATE

You must surrender your pistol license to this office if you no longer maintain a residence (pay real property taxes) in NYS. All handguns need to be given to an FFL Dealer to be transferred out of state. You will then need to bring us a copy of the bill of sale as well as your pistol license. Your license will then be surrendered. If you move back to NY, you will have to reapply.

DECEASED PISTOL LICENSE HOLDERS

Weapons belonging to a deceased pistol license holder must be either surrendered to the Onondaga County Sheriffs for safe keeping by calling the non-emergency number at (315) 425-2111, sold to a licensed FFL Dealer, or transferred onto an immediate family members pistol permit by the executor within 15 days of the holders passing. Required documentation to make a transfer to an immediate family member are as follows:

- 1. Copy of the Death Certificate
- 2. Copy of the Will/Surrogates Court paperwork showing who is Executor
- 3. Handgun Sale Affidavit (Notarized if Executor is not present)
- 4. Pistol Permit of the deceased pistol permit holder

All weapons that are transferred to a NYS FFL Dealer or picked up by a law enforcement agency must have documentation, a copy of which needs to be provided to the Pistol License Unit showing that transfer.
